### OPENING REMARKS BY FABC PRESIDENT DAVE AIDNEY

On behalf of my fellow President of AFBC Geoff Shaw and our FABC Execo Team - Welcome & Bula Vinaka to this wonderful venue at the Fiji Marriott on Momi.

When our VP Warwick picked this location as our venue it was on the basis that many of us had not been here and wanted to do something different that created the WOW factor.

Warwick and our Forum planning Team have had many a late night pulling all of this together and as with all major Forums we have had our challenges.

The biggest challenge has been the strong turn out and our apologies to those who were not able to secure accommodation as we simply took every room that the Marriott had on offer and ran out.

Our program today has been a moving target and has changed considerably from what we drafted up at the outset.

A special Thank You to Australia's Assistant Minister for Trade Hon. Mark Coulton for taking time out to join us, especially given his recent cabinet reshuffle in Canberra.

Also to our Minister for Trade and Tourism for accepting our invitation to be our Chief Guest. Our Government has been strong supporters of FABC and our joint Forums.

Today is Fiji Climate Change Day and wearing my Hon. German Consul hat – I would like to take this opportunity to congratulate our Prime Minister and his Team for taking on the Presidency of COP23 and bringing our Climate challenges in the Pacific to the global stage. Celebrations are being held today for climate change and all going well our AG & Minister responsible for Climate Change may be able to join us later today or this evening.

At FABC, we have been concerned about a number of issues including:

 Our decline in Tourist arrivals from Australia which represents at least 45% of our arrivals.
I was pleased to read recently that out of the 88,693 arrivals in August, this represented a 7.7% increase on the same period last year with a marginal 0.8% increase for visitors from Australia.

Not a decline but we must be careful about pricing ourselves out of the market as a possible 10% decrease from such a major source would have a major impact on our local industry.

» We have also been concerned about our gradual decline in ratings on the Ease of Doing business in Fiji.

Today, we are going to put a positive slant on this and seek from you all what we can do to improve on our ratings.

Fiji has huge opportunities and we welcome our Australian Trade delegation we have with us today - led by Adrian Weeks who are exploring exciting opportunities in Fiji. They come from a varied field and I would encourage all of you to engage with them and help make things happen.

I am told that Assistant Minister for Trade – Hon Mark Coulton comes from a farming background and I see from the recent Cabinet reshuffle that he is one of the few survivors.



Minister – as you would appreciate – Fiji has untapped opportunities in Agriculture and anything you can do to help us harness these would be much appreciated.

Some of you may not be aware but every week we airfreight to Los Angeles 20 tonnes of fresh turmeric and ginger which is grown wild and deemed to be organic. Apparently the Americans consider Turmeric as the latest health tonic as the Germans and French discovered with our Kava 10-15 years ago when we were airfreighting large quantities of Kava to Germany and France who were producing Kavakava capsules.

The larger pharmaceutical companies became concerned and kava became a banned substance until the full status was known. Now that the ban has been lifted, our Kava price has increased to \$120 per kilo and revenue earned from home consumption is now probably on par with our Sugar Cane earnings.

The opportunities that our local medicinal / herbal products have to offer are abound and offer Fiji great opportunities.

We will be discussing these throughout today along with our ongoing challenges re – Productivity ensuring that we are internationally competitive.

This afternoon's session will be focused on our TCF industry but the same applies to our ongoing challenge to make Fiji – the "Hub of the Pacific" not for cocaine and or Ice and those brown parcels that are being found washed up on beaches but for shipping.

Tax matters are also part of our Forum and whilst we all want to encourage Tax Compliance, sometimes the big stick approach turns away possible would be investors rather than dealing with the limited few who are trying to beat the system.

This Forum would not have been possible without the hard work of our Execo Team & Secretariat.

Thank you Warwick for taking on the challenge. It will probably be the last time you will volunteer to do this.

Thank you Saud for helping us get our Website reignited, and Ronna & her Team at <u>The Greenhouse</u> <u>Studio</u> for helping us pull this together in such a short time and helping us with this Forum.

To HE. John Feakes and your Team at Australian High Commission, especially Amy and Sophie for their ongoing support and for

our Execo for being there to stand in when required.

I would like to acknowledge and thank all of our Past Presidents, some of whom accepted our invitation to join us at this forum.

To James Huey who helped set up FABC in 1986 and to Ikbal Jannif who took over from James, and I am told is the only President who did two terms.

To those Presidents who helped guide FABC through troubled waters during a Coup or two, Trade Bans and sanctions and did everything they could to help restore our Fiji/ Australia bilateral relations.

Our thoughts go out to our past Presidents who are no longer with us today but played a major role in helping us bring FABC where it is today.

This forum would not have been possible without the generous sponsorship received and whilst our sponsors will be acknowledged throughout the day, I would like to pass on my token of appreciation for the same.

By the end of today, we will have a list of Key Outcomes and Action Items which our newly elected EXECO will use to work on throughout the year. They will keep you all informed and will co-opt your assistance when needed.

Thank you for being here and we look forward to a fruitful day of deliberations.
